



IICS TUITION & FEES 2019–2020 SCHOOL YEAR

1. APPLICATION FEE:

(one time only,
for new students only)

Each new applicant is required to pay a one time Application Fee.

\$1,160

Applications will be processed only upon receiving the Application Fee.

This fee is only refundable if the applicant withdraws their accepted/approved application due to a waiting list interval of more than 2 (two) academic years.

2. CAPITAL LEVY FEE:

(one time only)

A one time Capital Levy Fee per student is payable for all students upon starting Grade 1 or above. Students in EY3, EY4 and EY5 will pay the Capital Levy Fee once they are in Grade 1. This fee is assigned to a fund designated for capital investments (such as expansion of the physical facilities) and campus development (such as the improvement of resources, upgrading of technology, etc.). The Capital Levy Fee is due on **August 1st, 2019**. This fee is non-refundable. All students Grade 1 and above must have completed their Capital Levy Fee payment by **August 1st, 2019**.

3. ENROLLMENT FEE:

(yearly recurring)

Enrollment Fee for Early Years (3 & 4 year olds)

Enrollment Fee for Early Years 5 through Grade12

The Enrollment Fee is an annual fee applicable to all students. Payment of the Tuition Fee is due ten days after acceptance to secure the place. The Enrollment Fee is non-refundable. The school cannot guarantee a seat to any student for whom the Enrollment Fee has not been received. Students will not be registered for the school year if the Enrollment Fee has not been paid by the due date.

4. TUITION FEE:

(yearly recurring)

The Tuition Fee is an annual fee. Tuition must be paid by all students by **August 1, 2019**. For students entering at the start of the school year, the Tuition Fee must be paid in full before the student may begin attending school. No child will be allowed to start attending school until the entire Tuition Fee has been paid.

Every payment should include specification of the student's name, surname, grade, and the school year for which payment is being made.

School Fees Include

Hot lunch, local field trips, overnight class trips for grades 4 through 12, school books and basic school supplies, yearbook, and specified (but not all) after school athletics and activities. The fees include 8% VAT.

School Fees Do Not Include

Laptops (required for Grades 6-12), headphones, PE uniforms, Grade 12 IB examination fees, DP (Grades 11&12) online courses, CEESA trips, school transport, health insurance, and the costs of certain school activities. In all cases these costs are communicated in advance to parents.

Technology for Grades 6-12

Students are required to use laptops at school. Students in Grades 6-12 must use a Macbook laptop. Students in Grades 11 & 12 may use a PC if preferred.

Payment & Billing

Payments will only be accepted in US Dollars. Transfers are subject to a bank charge, which may be deducted by your bank. Please ensure that the full US Dollar amount of all fees is transferred to the IICS bank account. The remitter will be responsible for any shortfall resulting from currency exchange discrepancies or bank charges.

Students will not be allowed to begin classes if fees have not been paid before the first day of classes. If payments are overdue, the school may prevent students from taking examinations, or from receiving reports or records. Late payments will be charged a rate of 1.5% interest per month on the total unpaid balance as of the last day of the month.

Families will receive invoices for the Tuition on a monthly basis between September 2019 and June 2020. Families will receive invoices for the Capital Levy Fee and Enrollment Fee in August/September 2019. Electronic invoices are issued in the name of the student and sent via e-mail to parents.

Late Enrollment & Early Withdrawal

For students withdrawing before the end of the year, the tuition is partially refunded based on the school policy. The Application Fee, Capital Levy, and Enrollment Fee are all non-refundable.
